On Monday, December 6, 2021 at 5:00 p.m., the City of Wauchula Commission met for its regular scheduled workshop.

## Nadaskay called the workshop to order.

Commissioners present were Mayor Pro-Tem Neda Cobb, Russell Smith, Mayor Keith Nadaskay and Gary Smith. Commissioner Sherri Albritton arrived at 5:06pm.

Also present were City Manager Terry Atchley, Assistant City Manager/Police Chief John Eason, Assistant City Manager/Finance Director Sandee Braxton, Deputy City Manager Olivia Minshew, Community Development Director Kyle Long, Community Redevelopment Director Jessica Newman, Director of Project Management and Procurement Ward Grimes, Communications Coordinator Cheyenne Pohl, City Attorney Kristie Hatcher-Bolin and City Clerk Holly Smith.

Minshew addressed the Commission and explained the Townsend Street project. Minshew stated there was a concerned resident Roy Bolin that had questions regarding the property line and the possibility of saving trees from being removed due to the project.

Bolin addressed the Commission and stated he did not have a problem with a retention pond being built but would like to preserve the trees no matter whose property they were on. Cobb stated Bolin had contacted her and she advised Bolin to attend the workshop. Minshew stated the surveyors would be back Wednesday to do another survey. Minshew added after the survey was completed the findings would be sent to the engineers. Minshew stated the city would do it's best to try and save the trees. Long explained the property markers he had found on Bolin's property and added the parcel are subdivided and not platted. Long noted there was a discrepancy with the survey markers. Bolin again expressed his desire for the city to try and save the trees. Nadaskay informed Bolin city staff would resolve the issue and would be in contact with him.
