810 S 9th Avenue Old Case - 18-238-M Ramiro Jr. & Rebecca Briones

CE Officer Bergens testified for the record this case is compliant and closed; no discussion was held.

New Case – 19-056-UDB 213 Short Sheet **Robert A & Blanche C Rogers** CE Officer Bergens testified and presented photographic evidence which Special Magistrate Dawson accepted. Bergens explained the property owner lived in Delaware and sent an email explaining they needed more time to make the repairs. Bergens stated there were more cases on the property, but the property owner had taken care of them. Special Magistrate Dawson asked for the email to be placed in the record. The email explained that 213 Short Street was going to be put in the property owner's brother's name and with the proceeds from the sell of 219 Short Street would allow him to fix 213 Short Street. Special Magistrate Dawson granted an extension for 60 days and encouraged the respondents to file probate proceedings within 60 days and provide updates to code enforcement as probate proceeding progresses.

New Case – 19-058-UDB 219 Short Street **Robert A & Blanche C Rogers** CE Officer Bergens testified and presented photographic evidence which Special Magistrate Dawson accepted. Bergens explained the condition of the property and house and stated she was not opposed to working with them. Special Magistrate Dawson granted an extension for 60 days and encouraged the respondents to file probate proceedings within 60 days and provide updates to code enforcement as probate proceeding progresses.

New Case – 19-076-L 409 Walton Avenue Kevin L Collazo CE Officer Bergens testified for the record this case is compliant and closed; no discussion was held.

New Case – 19-077-NA 409 Walton Avenue **Kevin L Collazo** CE Officer Bergens testified and presented photographic evidence which Special Magistrate Dawson accepted. Bergens explained the property owner was in prison and had been for over a year. Bergens stated there were numerous untagged vehicles in the yard. Bergens added Collazo's brother had been in contact with her and explained that he was trying to mow the yard monthly and was trying to contact his brother regarding removing the vehicles. Bergens asked Special Magistrate Dawson for guidance on how to address the case. Special Magistrate Dawson replied a deadline for compliance needed to be set and contact made with Kevin Collazo to relay my ruling. Special Magistrate Dawson gave an extension for 60 days (August 19, 2019) with a fine of \$100.00 a day if not in compliance after the 60 days and gave the City the authorization to abate.

New Case – 19-085-NA 835 Tennessee Street **Dottie Allen**

CE Officer Bergens testified and presented photographic evidence which Special Magistrate Dawson accepted. Bergens stated the case was opened on May 6, 2019 and the vehicles were still there today and she has had no communication with the Allen. Bergens stated the issue was the unlicensed vehicle as well as the inoperable vehicles. Special Magistrate Dawson gave an extension of one week (June 26, 2019) with a fine of \$100.00 a day if not in compliance after June 26, 2019 and gave the City the authorization to abate.

New Case – 19-100-NA 410 Ohio Avenue Howze & Kazen Partnership

CE Officer Bergens testified and presented photographic evidence which Special Magistrate Dawson accepted. Bergens stated the case was opened on May 22, 2019 and today the hood was up on the vehicle and she did not oppose giving them a few more days to move it. Special Magistrate Dawson asked if the truck was tagged.

Bergens replied no. Special Magistrate Dawson gave an extension of two weeks (July 3, 2019) with a fine of \$50.00 a day if not in compliance after June 26, 2019 and gave the City the authorization to abate.
