- 2. Provides technical support for other operators.
- 3. Ensures safe, effective operation of plant facilities.
- 4. Conducts frequent and periodic inspections of plant to detect malfunctions, initiates corrective actions.
- 5. Ensures maintenance of accurate and complete records on plant operation and laboratory data.
- 6. Executes work and maintenance schedules, ensures that building, grounds, and equipment are maintained in proper condition.
- 7. Learn to perform routine laboratory tests, samples according to set tests, samples according to set test schedules.
- 8. Assists in formulating and implementing practice rules, techniques, and procedures.
- 9. Ensures safe use of all chemicals and mechanical treatment related supplies.
- 10. Reads and records daily equipment readings, and makes adjustments to the equipment based on guidelines set by the Department's policies and procedures.
- 11. Performs interior and exterior building maintenance and housekeeping chores and grounds maintenance tasks.
- 12. Performs preventive, actual and emergency maintenance on electrical and mechanical plant systems.
