# City Manager

Honorable Mayor, City Commissioners and Residents of the City of Wauchula,

I am pleased to present to you the Annual Report for the fiscal year ending September 2023. As we reflect on the past year, it is evident that Wauchula has achieved significant milestones and progress in various areas that contribute to the well-being of our community.

We kicked off Fiscal Year 22-23 in recovery mode from Hurricane Ian. Our team responded safely and efficiently clearing right of ways, restoring utilities, repairing major washouts of roadways and rehabilitating city facilities that suffered flood & wind damage. We continue to work through the logistics of both FEMA and insurance reimbursements to this day.

We were successful in our efforts to secure over \$14,000,000 in funding appropriations from the State of Florida during the 2023 legislative session. At a local level, the Economic Development Authority also supported our requests for funding, resulting in \$900,000 in grant funds. These external funding sources help to stretch our dollars and keep projects moving forward. Projects are not possible without proper planning, design and funding to support them. Our team has been busy the past year making sure that those needs are met by completing items such as:

- Secured new Purchase Power Agreement with Florida Power & Light for bulk power supply
- Secured Master Consulting Agreements for civil, utility & stormwater engineering services
- Secured Master Consulting Agreement for aviation engineering services
- Completed a water/wastewater rate study and implemented recommendations
- Began an electric rate study

All of this and more happened without skipping a beat during and after significant staff changes, i.e. a new City Manager, Deputy City Manager, City Clerk, Finance Director, Chief of Police and Assistant Chief of Police. I extend my heartfelt appreciation to our city staff who work hard for our community. They exhibit our values of Integrity, Servant Leadership, Excellence and Engagement in their daily actions. It is an honor to serve the City of Wauchula alongside such amazing people.

As we look ahead, the Wauchula community can anticipate continued development and enhancement to our services. We remain committed to providing exceptional service, maintaining a safe and inviting environment for a united community. I know we will continue to build on our achievements and I am excited for our future!






# **FINANCE**



The City of Wauchula Finance Department is committed to providing the highest levels of financial services to the public and user departments. This includes insureing that proper controls and procedures are in place to manage and protect the public's resources. We regularly evaluate and balan our service levels, customer needs, efficiency and available resources. The City Finance Director plans, organizes, provides administrative direction and oversight for, and participates in, all financial and related functions and activities, which includes investments, financial transaction processing, record keeping and reporting, payroll, utility billing, and information system technology; functions as the Chief Financial Officer for the City; coordinates the production and the administration of the City's budget; provides expert professional assistance to City management staff in areas of expertise; fosters cooperative working relationships with regulatory agencies.



The Finance Director also oversees, directs and participates in all activities of the Finance Department, including the treasury and budget functions. The work involves both the oversight of functions and activities and performance of many of the reporting, reconciliation and other day-to-day functions. Responsibilities include coordinating the activities of the department with those of other elected and appointed officials and managing and accomplishing the complex and varied functions of the department. The incumbent is accountable for accomplishing departmental planning and operational goals and objectives and for furthering City goals and objectives within general

policy guidelines.

### **HUMAN RESOURCES**



The Human Resources (HR) Department has made it their goal to foster a healthy, prosperous work environment that is always improving. To achieve this, the following practices have been put in place:

- Successfully completed another open enrollment along with the transition of Albritton Ins. to Acentria Insurance.






### PURCHASING DEPARTMENT



The purchasing department ensures the City's purchasing policy is followed as it facilitates all the necessary purchases for the City, everything from office & operating supplies to trucks and equipment, and everything in between. The centralized purchasing process ensures an efficient means to keep the City fiscally responsible and avoid waste.

We continue to look for more efficient/better ways to maintain & track inventory, equipment & facilities maintenance. The work order system allows for data driven purchasing decisions when it comes to facility repairs/maintenance and equipment and truck replacements.

The fleet replacement program and capital improvement plan allows for a planned approach to larger capital purchases rather than a reactionary approach.



For example, this year the City was able to purchase an additional dumpster truck while retaining the existing dumpster truck as a backup. This has been a much-needed addition to ensure a viable plan when the inevitable breakdown occurs.Other notable capital purchases in this area this year were two fleet trucks, three facility air condition units, and a new lawn mower.

### WAUCHULA MUNICIPAL **AIRPORT**



City Staff manages the day-to-day operations of the airport and oversees the planning and grant funded projects at the airport. Projects including a Taxiway Resurface, Lighting & Marking project, a Runway Extension & Fuel Farm project, a Pilot Lounge Rehab & T-Hangar Construction project, are currently underway or soon to be. Currently there is \$11.8 million in active grant projects at the airport. Our small general aviation airport, "In the middle of nowhere," had over 22,000 operations each of the last two years. Wauchula Municipal Airport(WMA)t hosts the annual Bensen Days Gyro plane/Gyro copter event.It is one of the two largest such events in the world. WMA has hosted this event now for 50 years. There are a number of flight schools from both east and west coasts that utilize our airport for flight training. Several paramotor schools are held on-site each year as well. WMA is also home to Harvest Aviation, a Non-Profit mission organization that completed project at the airport fly supplies monthly to Belize and


The Automated Weather Observing System provides continuous and real-time weather conditions at the airport by measuring meteorological parameters, reduces and analyzes the data via computer, and broadcasts weather reports which can be received by aircraft operation up to 10,000 feet AGL (Above Ground Level) and 25 nautical miles from the AWOS.

### POLICE DEPARTMENT



There has been significant personnel movement within Wauchula Police Department. With the promotion of our previous Chief John Eason to Deputy City Manager along with a couple of retirements, WPD has promoted members to the positions of Chief, Assistant Chief, Lieutenant, Sergeant, Detective Sgt, and Detective and hired several new officers. All promotions were awarded to highly qualified and experienced members of WPD. This is a testament to the quality of the members within WPD. Brandon Ball was the last member of the department to be hired into a supervisory role from outside the department. Our goal is to never hire an external candidate for a promotional opportunity within the department. We pride ourselves on succession planning and the development of talent within the ranks of the Wauchula Police Department, exemplifying our core tenants of Value, Integrity, & Pride.





# Even with all the adjustments the Police Department has not been slowing down on their desire to provide a safe and secure enviorment for their community.

Assistant Chief Tom Fort is currently attending the prestigious and highly regarded FBI National Academy. A 10-week course in Quantico, Va. designed for senior law enforcement executives. The selection process for attending this training is HIGHLY competitive and Assistant Chief Fort's selection and attendance is a REALLY big deal. Wauchula Police Department last had a member attend this training in 2009. Assistant Chief Fort's training at the FBI-NA also earns him credit through the University of Virginia. Those credits will transfer into UCF where he is currently pursuing a Master's Degree and schedulde to graduate in late 2024.

### POLICE DEPARTMENT



- Successfully replaced the weapons our officers carry every day. We rolled out modern handguns with optics. We are the first agency in the Heartland to transition to optics on handguns. Our yearly proficiency scores went through the roof. Officers completed over 30 hours of advanced transition training and are outfitted with new handguns, optics, weapon mounted lights, and new holsters This transition resulted in our officers reducing the overall weight, length, and footprint of the weapon and holster while simultaneously increasing ammunition capacity. We are about to assist the Hardee County Sheriffs Office who is following our lead.
- Successfully replaced the long-guns (rifles) our officers carry. The old weapons were literally Vietnam era military surplus rifles. We replaced the weapons with a modern version which is shorter and lighter and is outfitted with modern optics and lighting systems.
- Successfully implemented ALPR technology (Automated License Plate Readers) within the City of Wauchula. This technology has been instrumental in traffic enforcement by identifying missing persons, wanted persons, stolen vehicles, etc.
- WPD continues to "freshen up" the appearance of WPD equipment, uniforms, and vehicles. We rolled out a community designed uniform patch our officers wear every day. We also implemented new graphics on police vehicles that have garnered significant positive comments from staff and community members. We will continue to outfit new vehicles as they come in each year.



 WPD participated in a community engagement challenge that encouraged members of the department an members of our community to tale selfies with one another t foster and develop the relationship with those we serve. The winners from the community and from the WPD were awarded steak dinners cooked by the Chief. It turned in to a department wide dinner with many members of our community coming together to have a meal with one another. This event garnered a ton of positivity and was a big hit on our social media page (Facebook).

### **CITY CLERK**



The City Clerk is responsible for preparing agendas and attending City Commission workshops and meetings, as well as meetings for all boards and committees of the City. As the custodian of the official records of the City of Wauchula, the City Clerk records and maintains all proceedings of these meetings, as well as prepares minutes for each. The Clerk's Office also facilitates bid openings for advertised projects and services, prepares legal notices for publishing, administers the City oath to all new employees, and serves as an internal auditor, reporting findings to the City Commission as needed.



In 2022, our community was threatened by another major hurricane. The Clerk's Office ensured that the records of the City were well protected, that notices of emergency meetings and special meetings were published in accordance with Florida Statutes and minutes were readily available.

During this fiscal year, the City Clerk's Office completed an annual destruction of approximately 2,400 pounds of paper records that met retention and submitted the annual compliance statement to the State of Florida as required by Florida Statutes. The City Clerk continued to oversee all public records requests to ensure compliance with Florida Statutes by providing all records in a timely manner.

# ROAD MAINTENANCE DIVISION



The mission of the Streets and Roads Maintenance Division is to provide for a safe and well-maintained streets and roads system. With a new fiscal year upon us, the Streets & Maintenance Department offers you a look back at some accomplishments in 2023.

#### LOUISIANNA STREET SIDEWALK PROJECT

This sidewalk begins at the entry of our new subdivision Hidden Creek and connects to Florida Avenue. It consists of:

\*Approximately 7,500 ft of new sidewalk

\*Approximately 160 Yards of Concrete

\*800 ft ff safety railing (Ditch Area)

#### **NEW STREET SIGNS DESIGN**

A large percentage of the city's street signs were worn & faded.

We knew it was time to address this issue, but while we were at it, why not change things up a bit and go with a different design, which includes our city logo, like most of us have seen in some other cities.

This project takes careful planning to be assured that all street names & block numbers are correct, before ordering.

To date, we have installed new signs, including updated stop signs & reflectors, to the entire Southeastern side of the city, and currently in the process of distributing to the Northeast.



### STREET LIGHTS RESTORATION IN BRIARWOOD

The street lights in Briarwood subdivision are identical to those on East & West Main St. While their antique style is adored by many, age was beginning to show & we addressed some needs:

# PARKS AND RECREATION



The City of Wauchula Parks and Recreation Division is as diverse as the community it serves. Services provided range from weekly playground maintenance and inspections to manicured lawn and garden care as well as washroom maintenance, irrigation and tree management, and taking care of the City Cemetery.

In addition to parks and green spaces, Wauchula staff maintains over 2 miles of trails providing over 10,000 feet of developed walkways throughout Peace River Park.

### WATER AND SEWER DEPARTMENT



Along with their day-to-day duties of caring for our water and sewer system, the crews have completed 5 manhole rehabilitation projects this year. Manhole rehabilitation is the process of reinforcing and restoring an aging manhole after years of wear and tear to avoid full replacement. Rehabilitation is essential for manhole maintenance to revitalize existing structures and steer clear of disaster down the line. Damaged manholes are susceptible to inflow and infiltration which stem from excess ground or stormwater seeping through cracks or holes in

the manhole structure. Structural collapse is a worst-case scenario but


### WATER/WASTEWATER DIVISION



The City staff for the plants includes five dual certified operators. They are certified in both water and wastewater and rotate between the two plants. The city also has a laboratory technician that is capable of running samples for both water and wastewater. The plant is capable of supplying over 4 million gallons of water per day. The water is aerated, disinfected and also injected with an antiscalant that helps prevent corrosion in the pipes of the distribution system. The water storage capacity is 800000 gallons. The City's water and wastewater plants have onsite power generation that allows them to continue operating even in the event of a power outage. There is also a SCADA system that allows the operators to monitor and control plant equipment through text messaging without having to be on-site.

- Sludge Site Inspection (in compliance)
- Began construction on new digester (a part of treatment at the WWTP)
- Began renewal process for WWTP 10-year permit

- Sampled lead and copper for schools and child care facilities (New Rule passed down from Department of Environmental Protection. We are one year ahead of schedule.)



### **ELECTRICAL DIVISION**



The City of Wauchula owns and operates a non-generating municipal electric utility system and currently receives its wholesale power from Florida Power & Light (FPL). The city reports all outages to Florida Municipal Power Agency for tracking. Our mission is to serve our customers with reliable, quality power and to provide service in a prompt courteous manner at competitive rates. The electric crew has been busy this past year with many new projects as well as maintaining our system and the day-to-day duties.
