Ordinance 2023-17 Extending the suspension and waiver of water and wastewater impact fees until February 1, 2025

1. Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals and welfare):

The City owns, operates, controls and manages an exclusive water and wastewater service area both within and without the City limits. The financing of central water and wastewater facilities is complex, requires extensive planning and engineering, and calls for advanced participation by the development community so that adequate public facilities can be provided to meet the impacts of that development. In 1982, the City adopted its first set of water and wastewater impact fees. The growth of the City has been stagnant for many years. In 2014, in an effort to support growth and development, the City suspended and waived the collection of water and wastewater impact fees. This ordinance extends the suspension and waiver until February 1, 2025. This ordinance serves the public health, safety and welfare by ensuring the publicly owned utility, which provides an essential service to the community, is prudently operated.
