The City intends to amend Chapter 18, Article IV, Sections 18-62 and 18-63 to make these sections consistent with Chapters 205 and 647, Florida Statutes and to amend Chapter 18, Article IV, Section 18-65 to clarify that, when the City Commission deems it appropriate or necessary, the business tax schedule shall be amended by ordinance instead of resolution. This ordinance serves the public welfare by ensuring the City collects business taxes consistent with Florida Statutes and allows for an additional opportunity for public comment on future amendments, if applicable.

- 2. An estimate of the direct economic impact of the proposed ordinance on private, forprofit businesses in the City, if any:

Business taxes are collected annually by the City of Wauchula and vary by type of business being conducted in the city limits. The schedule of tax ranges from \$15 to \$405.
