Ordinance 2023-09 Modifying Certain Meter Regulations

1. Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals and welfare):

The City is authorized, pursuant to general and special law and its home rule powers contained in statutes and the Florida Constitution, to own, operate, provide, and extend central water, wastewater, and reclaimed water services both within and without the corporate limits of the City of Wauchula, Florida, and the City, in fact, owns and operates a water and wastewater system, which provides services within and outside of the City's corporate limits.

The City has full and exclusive authority over the management, operation, and control of all of the City's utilities and the authority to prescribe rules and regulations governing the use of such facilities whenever such are provided by the City, and to make such changes from time to time in such rules and regulations as it deems necessary.

This ordinance amends the existing ordinance governing multiple units served by a single meter. The amendment serves the public interest by easing the difficulty of metering multi-unit developments through master meters rather than individual meters for each unit, which can be a financial burden.

2. An estimate of the direct economic impact of the proposed ordinance on private, forprofit businesses in the City, if any:

None. The proposed ordinance will not have any negative financial impacts to businesses. Allowing businesses to use a master meter for multi-unit developments, as opposed to requiring a meter for each unit, could potentially result in a financial savings for the business that develop, own and operate multi-unit commercial and residential properties.

4. Additional information the governing body deems useful (if any):

This Ordinance amending the City's code is an effort by the City of Wauchula to reduce the potential fiscal impact on businesses and property owners alike who own and operate multi-unit commercial and residential properties. The proposed ordinance is a generally applicable ordinance that applies to all persons similarly situated (individual property owners as well as businesses who develop, own, or operate multi-unit properties) and, therefore, the proposed ordinance does not affect only businesses.
